Key Points

What is a Voluntary Commitment?

A Voluntary Commitment (VC) is an initiative which contributes to the goals and targets of the Sendai Framework for Disaster Risk Reduction implemented by a single entity or jointly implemented by multiple entities.

VCs may be completely new initiatives, or they may be linked to a previously announced commitment. Several organizations made commitments before and during the Third UN World Conference on Disaster Risk Reduction (WCDRR) in 2015. Since then, significant progress has been made with their initiatives. The SFVC online platform is open to receiving both new and previously announced commitments.

More details regarding VCs can be found in other sections throughout this guideline.

What is the Sendai Framework Voluntary Commitment online platform?

The Sendai Framework Voluntary Commitments (SFVC) online platform is operated by the United Nations Office for Disaster Risk Reduction (UNDRR) in response to the United Nations General Assembly resolution calling for specific and time-bound VCs by stakeholders at local, national, regional and global levels in line with DRR strategies and plans to support the implementation of the Sendai Framework. The SFVC online platform serves to incentivize stakeholders to inform the public about their work, to provide a vehicle for sharing commitments and initiatives and for motivation toward the implementation of the Sendai Framework. Moreover, it creates a space for stakeholders to inform the public about their efforts and achievements, collaborate and share good practices, and find opportunities to maximize impact in relation to disaster risk reduction (DRR). By operating the SFVC online platform, the United Nations Office for Disaster Risk Reduction (UNDRR) can take stock and monitor the progress and impact of stakeholders towards the implementation of the Sendai Framework for Disaster Risk Reduction.



Who can submit Voluntary Commitments?

All organizations working in DRR such as local governments, private sector, civil society organizations, academia, science and technology, media, etc. are invited to submit VCs.

- Only individuals representing organizations (institutional entities) can submit VCs. Eligibility for submission of a voluntary commitment is attached to an implementing organization with a physical address.
- The registration of VCs will be done through a focal point system. Focal points (FPs) must represent the implementing organizations. Each VC must have at least two FPs and one of them should be designated as a Main FP. Only the designated Main FP can edit the VC, while all registered FPs have access and can see the VC's submission details.

National governments and UN agencies should not submit their voluntary commitments on this platform if their initiatives are being solely implemented by national governments or UN agencies respectively.

- National governments are requested to submit their commitments to the [Sendai Framework Monitoring Tool](#) when their commitments are purely and solely under the initiative, operation and leadership of National Governments.
- For UN agencies, the UN Plan of Action for Disaster Risk Reduction for Resilience is reporting its progress annually regarding their direct contribution to the Sendai Framework. Therefore, initiatives that are purely and solely implemented by UN agency/ies without other stakeholders should be reported under the UN Plan of Action.
- For cases where an initiative is jointly executed by multiple entities (i.e., an initiative jointly implemented by national government agency/ies plus non-government organizations or local governments, or an initiative jointly implemented by UN agencies plus other non-government organizations or local governments), it will be regarded as a multi-stakeholder initiative and may then be submitted as a VC to the SFVC online platform.

What are the benefits of the SFVC online platform?




Figure 2 Benefits of the SFVC online platform

There are many benefits of submitting a VC and using the SFVC online platform has a great deal to offer to DRR stakeholders, UNDRR, and the general public alike. Figure 2 shows a summary of these benefits.


Stakeholders will be able to inform the public about their work, learn from each other, and be highlighted. UNDRR will be able to mobilize more stakeholders to implement more activities in DRR, monitor stakeholders' progress towards the implementation of the Sendai Framework and take stock of the overall contribution of stakeholders for DRR. Finally, the general public is also able to search for stakeholder commitments and get in contact with project proponents, get notified on specific interests including but not limited to regions, themes, and hazards, and be able to share stakeholder commitments on social media platforms.

How to submit and follow-up a Voluntary Commitment

Submission and follow-up of a Voluntary Commitment using the online platform are straightforward and self-explanatory. However, stakeholders are encouraged to read this guideline along with the Terms and Conditions¹ of the SFVC online platform to help clear any doubts and understand key additional information.

Figure 1 shows a visual presentation of the VC lifecycle, which consists of five steps from setting up an account to completion of a VC. For a detailed explanation of these steps, see the section on "[Making a Voluntary Commitment](#)" in this guideline.

Contextual Information

Sendai Framework Voluntary Commitments

The Sendai Framework Voluntary Commitments (SFVCs) initiative has its beginnings in the support of partnerships for Disaster Risk Reduction (DRR) expressed by the General Assembly (GA) resolutions [68/211 \(2013\)](http://undocs.org/A/RES/68/211)² and [69/219 \(2014\)](http://undocs.org/A/RES/69/219)³, which invite all stakeholders and their networks to contribute to DRR through Voluntary Commitments (VCs).

Subsequently, in the Third UN World Conference on Disaster Risk Reduction (WCDRR), held from 14 to 18 March 2015 in Sendai City, Miyagi Prefecture, Japan, UN Member States adopted the Sendai Framework for Disaster Risk Reduction 2015-2030, which was endorsed by the UN General Assembly following the WCDRR. The Sendai Framework is a 15-year, voluntary, non-binding agreement which identified the State as having the primary responsibility for DRR, but also underlined the shared responsibility of stakeholders such as local governments, private sector, academia and civil society, among others.

As a result, the GA resolution [69/283 \(2015\)](http://undocs.org/A/RES/69/283)⁴ called for specific and time-bound VCs by stakeholders at local, national, regional and global levels in line with DRR strategies and plans to support the implementation of the Sendai Framework. It also states that these VCs should be publicized through the website of the United Nations Office for Disaster Risk Reduction (UNDRR). The SFVC online platform was established within this context aiming to deliver the mandate given to UNDRR by the GA.

Purpose of the SFVC online platform

To start delivering on the mandate given by the GA, a strategy paper for the SFVC was developed in line with the overall UNDRR Partnership and Stakeholder Engagement Strategy. For implementing the strategy, the SFVC online platform was established in 2018 as a mechanism to mobilize, monitor and take stock of the commitments from multi-stakeholders in support of the implementation of the Sendai Framework until 2030.

The purposes of the SFVC online platform are:

- to incentivize stakeholders to inform the public about their work
- to serve as a vehicle for sharing commitments and initiatives and for motivating towards the implementation of the Sendai Framework
- to enable UNDRR to take stock and monitor the progress and impact

Throughout the development and maintenance of the SFVC online platform, its features and benefits have improved based on feedback from developers and users of the platform.

UNDRR SFVC team

As the administrator of the SFVC online platform, the UNDRR SFVC team reviews submissions of VCs from stakeholders; monitors the progress and reminds stakeholders to submit updates of VCs via progress reports and deliverables; and oversees the general functioning of the platform. The team also provides support to any stakeholder that may have questions about VCs and the SFVC online platform in general. The team also continuously strives to improve the SFVC online platform for better utilization by stakeholders. Finally, the team develops a Synthesis and Analysis Report of the SFVC initiative on a triannual basis in conjunction with the organization of the Global Platform for Disaster Risk Reduction.



Making a Voluntary Commitment

STEP 1: SET-UP AN ACCOUNT

The first step to making a voluntary commitment is setting up an account in the SFVC online platform.

To do this, you must go to the SFVC online platform at <https://sendaicommitments.undrr.org/>.

Once you click on the link or input the URL in your internet browser, you will be led to the webpage below.



The SFVC online platform is linked to PreventionWeb.⁵ This means that users must first register and create an account in PreventionWeb before being able to set-up an account in the SFVC online platform.

If you already have a PreventionWeb account, you may proceed to signing in using your PreventionWeb login credentials (email address and password). In case, you do not recall your password, you may click on “Forgot password” and you will be provided with instructions on how to retrieve your password.

If you do not have a PreventionWeb account yet, the SFVC online platform provides a link in the sign in page that will lead to PreventionWeb where you can register for an account. Information requested here are email address, name, organization and position.


Once this is done, you will have successfully registered and set-up your account.

STEP 2: COMPLETE YOUR PROFILE

The second step to making a voluntary commitment is completing your profile on the SFVC online platform.

Once you have signed into the platform, you will be requested additional information including your gender, street address, country or territory, city/town, and postal code. You will not be able to make edits to the information provided through PreventionWeb unless you make these changes through PreventionWeb directly.



UNDRR will not provide your information to any third party without your consent.


After this, you can then click on “Save profile” and complete step 2 of the VC lifecycle.

STEP 3: SUBMIT A VOLUNTARY COMMITMENT

Submitting a voluntary commitment (VC) will require you to provide detailed information about the relevant disaster risk reduction initiative that you would like to submit to the SFVC online platform.

The VC itself consists of seven sections:

1. Overview
2. Description
3. Deliverables
4. Budget and donors
5. Organizations and focal points
6. Topics
7. Social media and other info



Once submitted, UNDRR will review your VC based on good practice standards, which is also presented in this guideline.



The main focal point of a VC may make edits to the VC at any point in time after publication. This will be further discussed in a later section.

Deliverables

Deliverables are the end-products of your VC which showcase the results of your work and constitute a means of verification for the implementation of your VC. Thus, the submission of deliverables determines whether a VC will be considered completed.

Deliverables should match the description of your VC. UNDRR will review the logical consistency among the goal, objectives, and deliverables of your VC.



You may have one or more deliverables per commitment. UNDRR encourages submission of more than one deliverable that are distributed within the given duration of your commitment to validate progress.

However, if there is a large number of deliverables (i.e. more than 10), UNDRR suggests that deliverables can be grouped into categories and submitted as separate VCs.

After the submission of your commitment, UNDRR will review the information submitted. While the review is ongoing, you will not be able to make changes to your commitment.

Following the review, there are three possibilities:



If any information needs to be clarified, UNDRR will request clarification through the online platform and provide details about the clarification request through email. When a request for clarification is sent through the platform, your VC will be opened for editing. You will then be expected to respond to the clarification, and you may need to make edits to your commitment as appropriate. Once edits are resubmitted, UNDRR will review your submission again. UNDRR will provide as much support as needed throughout the process for publishing your commitment. You are highly encouraged to contact the UNDRR SFVC team for any clarifications or assistance required.



If a commitment does not follow the guideline, is not relevant or is not eligible, it may not be approved for publication.

A commitment is deemed not relevant if the submitted information does not provide enough information that links the commitment to the Sendai Framework and is not clearly contributing to disaster risk reduction. A commitment is deemed not eligible if it is solely implemented by a national government agency or by a UN agency. As noted in the Key Points, these commitments are monitored through different tools.



If no further clarifications are needed, your commitment will be approved and published on the SFVC online platform!

The status of your VC will be “Active” once it has been published in the platform. The status of your VC will change throughout the VC lifecycle and this will appear both on the full profile page and in the search engine.

Please note that until the commitment has been published, only the person who drafted, focal points registered, and UNDRR can view the information provided.


STEP 4: REPORT PROGRESS

After your VC is published, the next step of the lifecycle is to provide regular updates about your VC by submitting progress reports. This allows UNDRR and other stakeholders to be updated about your commitment, while also providing an opportunity for you to highlight the progress and achievements you have accomplished so far.

It is a simple and straightforward report submitted through the SFVC online platform consisting of five parts: 1) summary progress update; 2) achievements at a glance; 3) how are you assessing progress; 4) challenges in implantation; 5) steps for the next year.

The first two parts will be visible to the public once UNDRR has reviewed and approved your progress report, while the last three parts are only visible to UNDRR and the focal points.

The first progress report must be submitted six months after the VC was published. Subsequent progress reports will be requested every six months since the last published progress report as long as the VC is "Active", and its deliverables are not yet completed.

UNDRR will review the progress report after they are submitted. Progress reports (the parts visible to the public) will be available for viewing on the commitment’s profile page, under the section “Progress Reports & Deliverables.”

Notifications will be sent to remind you to submit progress reports for your VC. The status of your VC may change depending on the submission of Progress Reports. The following timeline for notifications and status changes is observed:

- Six months after the commitment is published, a first reminder to the focal points are sent. If a Progress Report is not submitted, a reminder will be sent every month.
- If a Progress Report is not submitted after three months (since the first reminder), the status of the VC changes to “Progress Update Needed”
- If a Progress Report is not submitted after six months (since the first reminder) and one year since progress update was received, the status of the VC changes to “Progress Not Updated”


The status of the commitments will appear both on the full profile page and in the search engine.

Progress Reports help UNDRR to take stock and monitor the execution of the VC. It also allows to ensure that VCs published in the online platform are active. Finally, the feedback will be analysed and included in the SFVC Analysis Report which will guide future actions.

STEP 5: SUBMIT DELIVERABLE(S)

As explained in Step 3, deliverables are specific outcomes or outputs that are produced from the execution of your VC. Deliverables constitute means of verification for the execution of the VC. Thus, their submission determines whether a VC has been completed.

You are expected to submit the outputs to your deliverables by the specified intended delivery date of your VC. Outputs are concrete evidence that verifies the progress of your VC.

Notifications will be sent to remind you to submit the outputs for your deliverables and confirm they are completed. The status of your VC will also change depending on the submission of your deliverables. The following timeline for notifications and status changes is observed:

- One month before the intended date of delivery, a first reminder to submit a Deliverable is sent.
- If a Deliverable is not submitted by the intended date of delivery, the status of the VC changes to “Deliverable Update Needed” and a reminder is sent every month.
- If a Deliverable is not submitted after three months from the intended date of delivery, the status of the VC changes to “Inactive”. An “Inactive” status means that your VC will no longer be visible to the public.

After all the outputs to deliverables are uploaded and the Deliverable is marked as complete, UNDRR will review the submission to ensure that all outputs are valid. Upon confirmation of the outputs, the latest version of the commitment will be published and the status of the commitment will change to “Completed”. The status of the commitments will appear both on the full profile page and in the search engine.

If a VC is unable to meet the specified intended delivery date of the deliverable, main focal points are encouraged to extend the due date by making changes to your commitment. See following section on [Editing a Published Commitment](#) for reference.

Editing a Published Commitment

A published VC can be edited to make changes to your commitment at any given time unless the VC has been submitted for review to UNDRR and the review is currently pending.

Upon signing in to the SFVC online platform, go to Home page and, under My Commitments, click on the commitment that you want to edit. Then, click the EDIT button. This allows you to make any necessary changes to your commitment and submit your commitment for review by UNDRR. UNDRR will review and verify the changes made before an updated version of the commitment is published on the SFVC online platform. The process for review is similar to the initial process of approval and publication of a VC. UNDRR may ask for clarification before changes are approved.

There are two categories of edition:

- **MAJOR:** A major edition changes the version number of your commitment to the next whole number. For instance, Version 1 to Version 2 to Version 3 and so on. Major editions include changes to the following: title of commitment, short description, description, geographic scope, expected duration, answers to narrative questions, progress report, deliverables, intended date of delivery, implementing organizations, and focal point information (adding, removing, change in organization)
- **MINOR:** A minor edition changes the version number of your commitment by increments of 0.1. For instance, Version 1.0 to Version 1.1 to Version 1.2 and so on. Minor editions include all other changes not classified as major. For example, other partners, photo illustrating the commitment, secured budget size, donors, social media & other info, budget scale, themes and issues, hazards, priorities for action, global targets, indicators and SDGs

The SFVC online platform automatically categorizes the type of edition and will provide a summary of changes made to your VC every time a version is submitted for review by UNDRR. The history of versions published can also be viewed by focal points.

Submitting Highlights

Highlights are short articles published in the SFVC online platform that features activities and achievements related to the platform and the published VCs within the platform.

Focal points can submit a highlight about their VC while their VC is being executed or after completion of their VC. This allows organizations to showcase their recent achievements and can also be an opportunity to discover new partnerships with other stakeholders. This may also serve as an incentive for existing and new partners to mobilize and accelerate their efforts and actions.

Submission of a highlight includes the following parts:

Once submitted, UNDRR will review the highlight before it is published to the SFVC online platform. UNDRR may request for clarification or edits made to the highlight by email. Once it is approved and published, the highlight will be featured on the home page of the SFVC online platform and will also appear on the VC profile page of the relevant VC.

UNDRR will send e-newsletters to stakeholders with the highlighted commitments, as well as the latest updates regarding the SFVC online platform.

Alternative methods of submission

In consideration of stakeholders with disabilities, elderly, and other special cases, UNDRR has also projected alternative ways for submitting a VC. If applicable, you may submit a VC through the following (UNDRR is not in a position to cover any cost incurred at the submitter side):

- A physical (printed) form filled by hand and sent by postal mail or fax
- A digital form in MS Word to allow submission by e-mail or fax
- A phone call to UNDRR Kobe Office: +81 78 262 5550 (applies only to stakeholders with disabilities or other special cases)

Other Features

Notifications:

As mentioned in the previous sections, the SFVC online platform automatically sends notifications to users depending on their preferences and their submitted commitments.

Once you have created an account and successfully signed in, notifications based on your preferences are consolidated in a weekly digest that is sent at the beginning of every week, while notifications based on your submitted commitments are sent on a daily basis. Notifications based on your submitted commitments include confirmation of new submission, confirmation of edits made to a commitment, request for clarifications from UNDRR, reminders for deliverables and progress reports, among others.

If you have not yet created an account and signed in to the platform and you have been made a focal point to a commitment, you will receive individual notifications as they are triggered by the system. You are highly encouraged to register and sign in as soon as possible to avoid receiving too many notifications from the platform.

Using the search engine:



Under the “Commitments” tab at the top of the SFVC online platform, you will see “Voluntary Commitments at a glance”. Here, users can search through the published VCs via the following:

- Name or ID number – enter keywords to search through the VC titles or ID numbers that correspond to VCs
- Organization – search VCs by implementing organization’s name, acronym or category
- Geography – filter by scope type, country/territory, or region
- Sendai monitor/SDG – filter by priorities, targets or SDGs covered
- Time frame – filter by duration of the commitment
- Status – filter by status of the commitment
- Issues & hazards – filter by themes and issues and hazards covered
- Beneficiaries & donors – search by donor name, acronym or category and filter by beneficiaries and budget scales
- Other – search by umbrella initiative or previously announced VCs

At the top of the search results, the applied filters are shown (“FILTERED BY”). Click the “x” sign to eliminate any filters you want to stop using. You may also use the “Reset” button to reset the filters at any time.

Contact the main focal point:

If you are interested in a particular commitment and want to get more information, go to the commitment’s page, and press the “Contact Focal Point” button. This will allow you to send a message to the main focal point of that particular commitment. Likewise, the main focal point of your commitment can be contacted by other people who are interested in your initiative. Hopefully, these exchanges can create synergies and opportunities for collaboration.

 Please note that UNDRR is not responsible and shall not be held liable for these communications.

However, if the main focal point has made their focal point information private, you may contact the UNDRR SFVC team at undrr-sendai-vc@un.org and the SFVC team will forward your message to the focal point.

Report an issue:

If the content of any published VC raises some concerns, there is a flagging system where stakeholders and public users can report an issue. The user must use their own discretion to carefully determine whether to flag a commitment and report an issue.

When reporting an issue, the user will be asked additional information stating the reasons why the commitment raises a concern. Links and supporting documents will be requested to support your claim. UNDRR will review these flagging reports and contact the focal point of the flagged VC. UNDRR can review and cancel the publication of flagged VC if necessary.

Share commitments on social media:



To share the commitment on social media platforms, go to the commitment's profile page. Click the sharing link button above the title of the commitment.

Delete your commitment:

If the organization/focal point wants to delete their voluntary commitment, they can send a request to UNDRR to delete their commitment. The request will be reviewed and if approved, the commitment will be removed from the SFVC online platform.

Link to PreventionWeb:

Published voluntary commitments will not only be viewed on the SFVC online platform, but also on PreventionWeb. If the organization has a profile page on PreventionWeb, the profile will be featuring the voluntary commitment(s), highlights (if their commitment was highlighted on the SFVC online platform), and relevant documents related to the commitment.

Usage of the SFVC Logo:

Stakeholders who have successfully published their voluntary commitments on the SFVC online platform are allowed to use the Sendai Framework Voluntary Commitments Logo to raise visibility of their commitment.

The Sendai Framework Voluntary Commitments logo may not be used for the following purposes:

- Promotion of products or services
- Commercial or personal financial gains

The use of the logo by non-UN entities does not imply the endorsement by the United Nations of such entity, its product, or services, planned activities or others.

Below, you may find two versions of the Sendai Framework Voluntary Commitments Logo. When using the SFVC logo, the ratio of the logo should be maintained to avoid distorting the image.

Based on that evidence, our commitment is to execute the program “Promoting Child-Centred Disaster Risk Reduction” with the goal of letting children understand hazards, learn about DRR and discuss how they can contribute to building resilience of their own communities in the countries of Japan, Philippines and Nepal. The objective is to organize seven workshops across three countries during the period of 2016 to 2020. The workshops will include both theoretical and practical components so that children can learn, discuss and implement the knowledge by conducting exercises such as town watching and simulations of evacuation. As a result, our commitment will produce the following outputs: Three publications (one for each country) from these workshops as educational and knowledge (including an evaluation of the program) materials. The publications will be completed by the end of the program in 2020. Children who are not attending these workshops can also learn from these publications in the future.</p> <p>We hope our program can not only train children but also help understand better ways to interact with them for DRR.</p> <p>- Yes. Because the Sendai Framework recognizes children as an important actor for changes, we decided to explicitly include DRR perspectives in our long-standing advocacy activities oriented at children. Also, our activities targeted at DRR and Children find greater justification when contrasted with the internationally agreed instruments rolled-out by the Sendai Framework.</p> <p>- Before the adoption of the Sendai Framework, our activities did not focus on DRR related perspectives. However, to respond to the all-of-society engagement principle stipulated in the Sendai Framework, we have started this new programme focusing on promoting child-centred DRR. Specifically, according to the Sendai Framework stance on the role of stakeholders, children and youth need to be recognized in DRR related legislation, national practice and educational curricula.</p>

Progress Report

- 1. Summary progress update (< 200 words)

- In the first six months, we managed to train personnel and conduct our first workshop about "Child-Centred Disaster Risk Reduction" in the country of Nepal. A number of 30 children between the ages of 10 to 12 years old participated. These children belong to local schools in the municipality of Bharatpur. It was helpful to have a clearly defined goal, scope and objectives as it allowed us to speed-up the definition of activities for the workshop. In the workshop, brief presentations by specialists and community leaders were combined with group dynamics. First, children learned about hazards. Then, they studied disaster risk reduction considering hazards in their communities. To put the knowledge in practice, town watching exercises and simulations of evacuation were scheduled (supervised by parents and teachers). We gathered relevant data before, during and after the workshop for evaluation purposes. This first experience provided a number of lessons learned. For example, we need to increase the involvement of parents to support and maintain activities that need to be executed as a result of the workshop.

- 2. Achievements at a glance (< 150 words)

- We: a) Defined contents for the workshop; b) Trained facilitators for Nepal; and c) Executed one workshop on "Child-Centred Disaster Risk Reduction" in Nepal with the participation of 30 children (10 to 12 years old) from the municipality of Bharatpur.

- 3. How are you assessing progress? (< 150 words)

- We are assessing progress in three ways: a) completion of tasks and budget; b) number of beneficiaries and c) impact of our program.
 a) We fulfilled the plan in terms of budget and execution of the first workshop during the first six months, but we need to start working in the publication for Nepal.
 b) We gathered data on attendance.
 c) In partnership with an academic institution, we defined a method for selecting participants and collecting data for evaluation purposes. We aim to determine if our program did indeed increase children's knowledge on DRR and generated ideas for building resilience that were eventually implemented in the community. In the future, we will explore conducting a Randomized Control Trial.



Appendix 4: Frequently Asked Questions

- *Can the details of the commitment change after publication on the online platform?*
 - Yes, details can be changed by updating the Commitment. See section “Making Changes/Editing the Commitment.”
- *Can the details of the commitment that was submitted at WCDRR in 2015 be updated?*
 - Yes, even if details of the commitment that was submitted previously did change, the focal point can update/add the new details.
 - If your previously announced VC has been already completed/implemented, please be encouraged to submit the updated information including the progress and deliverables retroactively, so that the online platform will be able to record and recognize such completed work.
- *My organization submitted a commitment before/at the Third UN World Conference on Disaster Risk Reduction in 2015, but it is not in the existing list of commitments.*
 - Please email the UNDRR Voluntary Commitments Team to inform them that the commitment is missing from the list, along with details of the commitment: when and where the commitment was submitted, the title of the commitment, focal point(s), and a brief description of the commitment.
 - The existing list of commitments has been made available after an intensive review of existing information (in several cases, the information was limited).
- *Why is the commitment flagged?*
 - A commitment could be flagged for numerous reasons, including misinformation, usage of the platform for commercial and advertisement purposes, etc. Users need to submit a form indicating clear reasons for flagging the commitment.
- *Can a commitment be submitted in other languages?*
 - The online platform is currently accepting submissions in English only. However, guidelines for submission in Spanish and French are planned to be available in the near future.
- *Can a single person submit a commitment? What are the minimum requirements to submit a commitment?*
 - Eligibility of submission of a voluntary commitment is attached to an entity with a physical address. This means that only individuals representing entities/organizations can submit a voluntary commitment.
 - For an individual representing an entity/organization, there is no minimum requirements such as educational background or years of experience.
 - Of course, the submitted commitment should provide enough information to determine its contribution to the Sendai Framework for Disaster Risk Reduction. This will be reviewed by UNDRR SFVC team.
